### FAMOUS TOYS CREDIT AGREEMENT LOGISTICS

DOES THE STORE HAVE A DOCK LEVEL RECEIVING?

(A dock, equipped with dock-levelers or dock plate, that a truck can back up to & unload a pallet from the truck directly into the store / receiving area)

Any further handling of the shipment by the carrier may be subject to an "Inside Delivery" charge. Famous Toys' shipping policy does not cover an Inside Delivery on any shipment. However, it can be requested at an additional charge to the outbound freight costs, up to 10% prepaid freight. Any unexpected Inside Delivery charges are the responsibility of the customer to pay, either by the carrier direct-to-store, or if billed to Famous Toys, adjusted on the shipment invoice(s).)
